Only owner-occupiers of properties which have been acquired by the Vendor for the implementation of the Vendor’s redevelopment project at Kowloon City Road / Sheung Heung Road (No.KC-007) and who have participated in the Vendor’s Flat for Flat Scheme and have entered into a “Flat for Flat” Undertaking (“<b>the Undertaking</b>”) with the Vendor (the owner-occupier(s) of each of such properties is referred to “<b>the participant</b>”) shall be eligible to purchase the specified residential properties in the manner as more particularly set out hereinbelow. At present there is only one participant eligible to purchase the specified residential properties as aforesaid.</li> <li>2. The time for selection and sale of the specified residential properties is as follows:  Date: 22 December 2015 to 23 December 2015, and 28 December 2015 to 31 December 2015 and 4 January 2016 to 8 January 2016 Time: From 10:00 a.m. to 1:00 p.m.</li> <li>3. If there are more than one participant, their priority of selecting and purchasing the specified residential properties will be determined by balloting. If balloting is required, the balloting will take place at or about 10:15 a.m. on 22 December 2015 at the Sales Office and the ballot result shall be posted at the Sales Office after the balloting.</li> </ol>	

4. The participants who are eligible to select and purchase and interested in purchasing any of the specified residential properties available for selection must bring along an authorization letter (in the form prescribed by the Vendor) duly signed by the participants in relation to release of security money paid by the participant under the Undertaking for payment of preliminary deposit and part payment of purchase price to the Sales Office. The participants whose identities have been verified by the Vendor shall proceed to select the specified residential properties which are still available at the time of selection.
5. The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and/or facilitating smooth sale of the specified residential properties, to adjust the time of the selection and sale. Any changes to the time of the selection and sale will be posted at the Sales Office. Participants will not be notified separately of such changes.
6. Each participant shall purchase no more than one (1) residential property of the Development.
7. If the participant has successfully selected a specified residential property, the participant shall personally enter into a Preliminary Agreement for Sale and Purchase of the selected specified residential property.

In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person by any method.

1. 只有其物業已被賣方收購以進行賣方於九龍城道/上鄉道 (No.KC-007)之重建項目及已參與賣方的「樓換樓計劃」並已與賣方簽訂「樓換樓計劃」承諾書(下稱「承諾書」)的業主-佔用人才符合資格以下述的方式購買指明住宅物業(每個該等被收購的物業的業主-佔用人或業主-佔用人們下稱「參與者」)。現時只有一位參與者符合上述資格購買該等指明住宅物業。

4. 符合資格及有意購買可供參與者揀選的指明住宅物業的參與者須攜同一份已由參與者簽妥的有關釋放參與者根據承諾書的條款已付的保證金以作支付臨時訂金及部份售價的授權信(其格式由賣方指定)到售樓處, 經賣方確認並核實身份後, 參與者可揀選當時仍可供揀選的指明住宅物業。
