The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

1. Each applicant under the Vendor's Subsidised Sale Flat Scheme ("**the Scheme**") has been allotted with a priority number ("**Priority Number**") which is generated by a ballot taken place on 2 March 2016 and the balloting result has been announced and available for inspection at the Vendor's designated website for the Development (www.urakaitak.hk) since 2 March 2016.
2. After the said balloting, Hong Kong Housing Society ("**HS**"), being the applications assessment organization appointed by the Vendor for the Scheme, has conducted assessment and interviews of the applicants from 15 March 2016 in order to verify and ascertain that the applicants meet the eligibility criteria of the Scheme set out in the Application Guide of the Scheme ("**the Application Guide**").
3. Only applicants who meet the eligibility criteria of the Scheme set out in the Application Guide as verified by HS ("**Eligible Applicants**") shall be eligible to select and purchase the specified residential properties in the manner as more particularly set out hereinbelow. The Eligible Applicants should receive a written notice issued by the Vendor on or after 24 March 2016 ("**the Notice**") informing the Eligible Applicant of the date and time that he/she shall attend the Sales Office for selection and purchase of the specified residential properties.
4. Eligible Applicant of 2 Persons or above Household (as defined in the Application Guide) may choose to add one of the adult family members included in the submitted application form for the Scheme ("**the Application Form**") as purchaser ("**the Additional Purchaser**") provided that the ownership shall be in the form of joint tenancy. Eligible Applicants of Single Person Household (as defined in the Application Guide) can only purchase specified residential properties marked with * in the above.
5. Eligible Applicants will be divided into groups ("**the Groups**") according to their Priority Numbers and shall be arranged to select and purchase the specified residential properties in batches in the order of priority according to their Priority Numbers.
6. The Groups of Eligible Applicants who shall be arranged to select and purchase the specified residential properties on the dates of sale set out in page 1 of this Information on Sales Arrangements are Group 1 to Group 64. The Eligible Applicants of Group 64 are restricted to those Eligible Applicants with Priority Numbers between S06001 to S12642 who have not previously attended the Sales Office for registration, selection and purchase of specified residential properties or those Eligible Applicants with Priority Numbers between S06001 to S12642 who have previously attended the Sales Office for registration but have not successfully purchased any specified residential property.

- (b) Each Eligible Applicant together with all his/her adult Family Members must bring along the following documents when they attend the Sales Office as mentioned in sub-paragraph (a) above:
- their Hong Kong Identity Card(s) or Passport(s) (as the case may be);
 - the Notice;
 - a cashier order issued in favour of “**Deacons**” for the sum of HK\$150,000 for payment of part of the preliminary deposit payable upon signing of the Preliminary Agreement for Sale and Purchase; and
 - a blank cheque for payment of the balance of the said preliminary deposit.
- (c) Each Eligible Applicant together with all his/her adult Family Members whose identities have been verified by the Vendor after registration shall proceed to make statutory declarations under the laws of Hong Kong at the Sales Office declaring that all the information and documentation supporting his/her application under the Scheme are true, correct and accurate to the best of their knowledge.
- (d) After completion of the statutory declaration procedure as mentioned in sub-paragraph (c) above, the Eligible Applicant shall proceed to select any of the specified residential properties which are still available at the time of selection in the order of priority according to his Priority Number.

Eligible Applicants can call 2784 6838 during the office hours (Monday to Friday from 9:00 a.m. to 5:30 p.m. and Saturday from 9:00 a.m. to 12:30 p.m. except Public Holidays) of the Vendor for flat viewing appointment but such flat viewing appointment should be arranged at least one day before the scheduled date of registration / flat selection of relevant Group of respective Eligible Applicant as set out in paragraph 6(a).
11. If at the commencement of the designated registration time slot for any Group set out in paragraph 6(a) above, all the specified residential properties which are marked with * in the above have already been sold by the Vendor, the Eligible Applicants of Single Person Household within that Group and the subsequent Groups shall no longer need to attend the Sales Office for selection and purchase of specified residential properties. A consumption table relating to the availability of the specified residential properties for selection by Eligible Applicants will be posted by the Vendor at the Sales Office. Eligible Applicants will not be notified separately of the progress of sale of the specified residential properties.
12. If at the commencement of the designated registration time slot for any Group set out in paragraph 6(a) above, all the specified residential properties set out in the above have already been sold by the Vendor, the Eligible Applicants within that Group and the subsequent Groups shall no longer need to attend the Sales Office for selection and purchase of specified residential properties.
